- *In case the application is presented for so called “ partnership accommodation“, the partnership accomodation application must be attached.*

- *Any applicant who will be assigned a bed and will not enter the dormitory accommodation without giving any reason (cancellation within 14 days prior to set date) may be requested to pay a monthly college fee.*

- *From 1.9.2007 any payment of the dormitory rent and other fees (visits, phone, etc.) shall be done in the form of encashment. That means, that in the Accommodation contract it is necessary to fill in the number of your account (eventually of the account the payments will be realised from) and when checking in at the dormitory a consent of the particular bank with encashment must be presented.*
