- 1) The completed application must be delivered to the Department of Accommodation Services of Administration of University Facilities (e-mail: Erasmus.accom@vscht.cz) **no later than on 24. 7. 2019.**
- 2) **Students newly applying for the accommodation at the UCT residence halls are obliged to pay an administration fee of 400,- CZK in advance (account number: 156290139/0300), in a note for recipient write date of birth in the form date; month; year (e.g. being born on the 26. 9. 1990 - 26091990) and your full name. A copy of the receipt confirming the payment of the administration fee is to be attached to the Accommodation application.**
- 3) **A refundable deposit of 3000 CZK is collected from foreign students when checking in at the residence hall (in cash directly at the respective residence hall), which is accounted on the day of the accommodation termination after the actual handover of the room and settlement of all obligations.**
- 4) A necessary prerequisite for the accommodation is **registration** for studying at UCT Prague.
- 5) The decision on the application settlement will be published at [www.vscht.cz/suz](http://www.vscht.cz/suz) from **12. 8. 2019.**
